

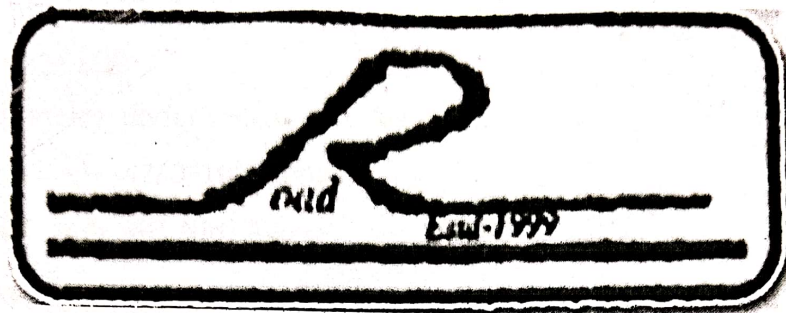

5. **Various day observations**: In this Financial year ROAD observed world environment day. This year we plantation of tree in our village. And our organization observed various day/divas.

6. **Training Workshop Participated by ROAD Personal:** Our ROAD staff attended various training and workshop in this financial year in different places and different Govt./Non govt. Department.
7. **General Meeting:** This year besides biannual session one General Meeting was held 24th july2022.
8. **Executive Committee Meeting:** In this year ROAD has been organized 4no 5 of executive committee meeting was held.

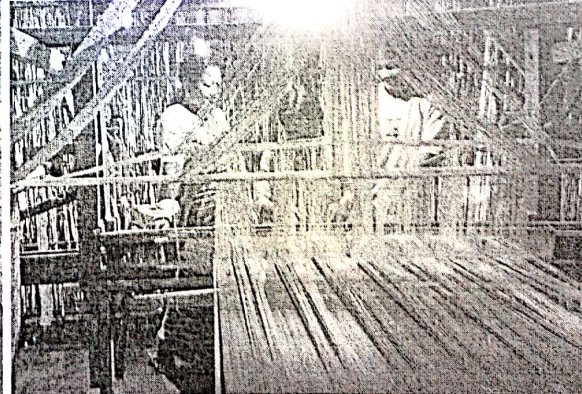
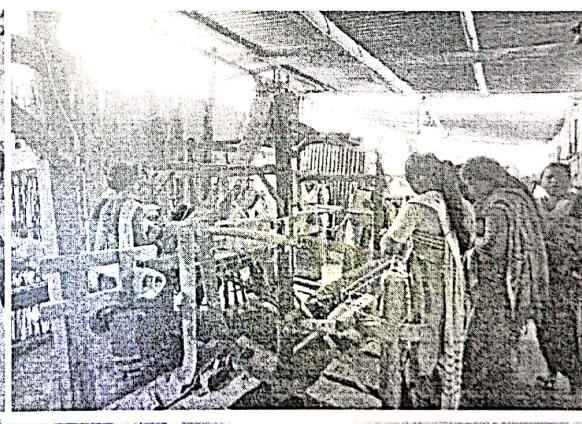
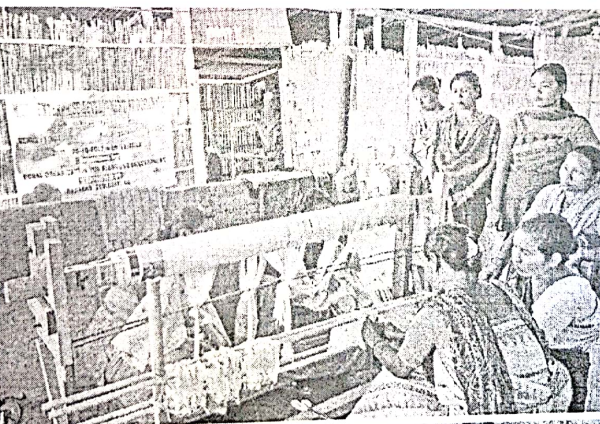
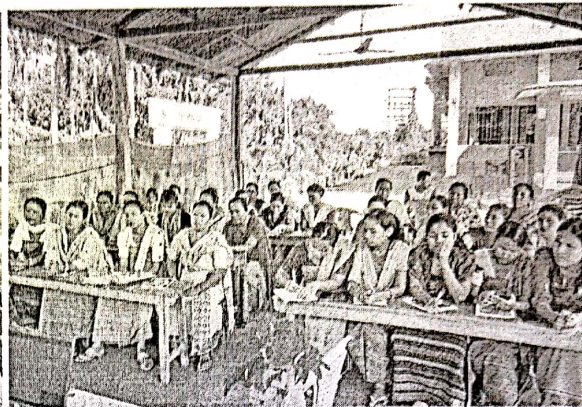

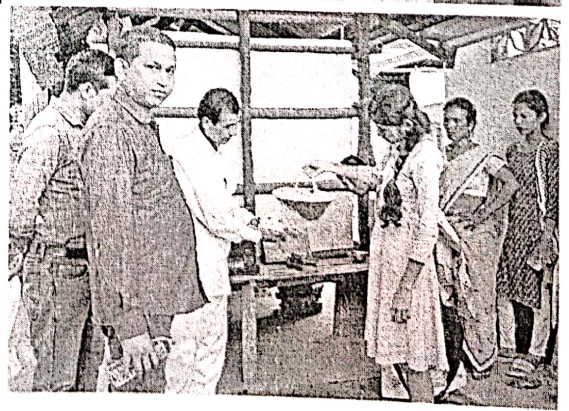
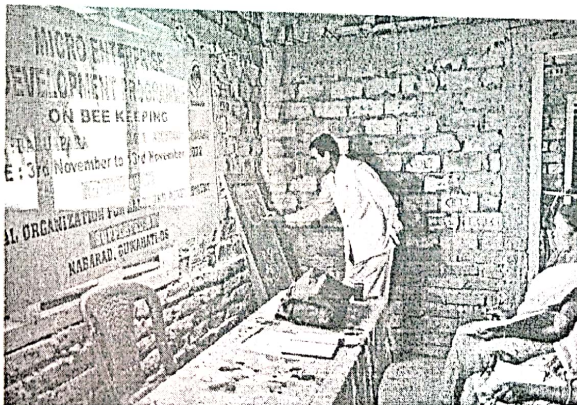
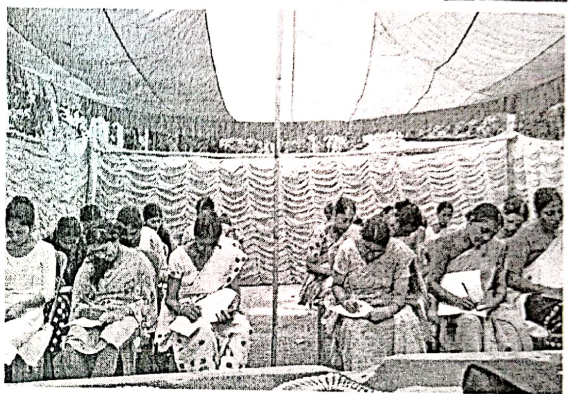
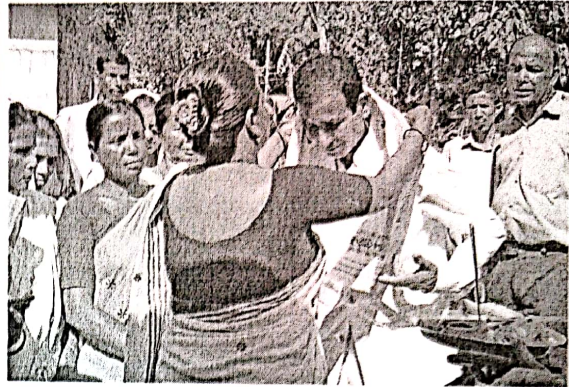
10. **Part Time Stuff:** ROAD appoint 7 No's part time worker in different villages and ROAD appoint part time stuff time to time in different project.

5. MEMBERSHIP:

Qualification to become Members:

10. QUORUM OF THE GENERAL MEETING:

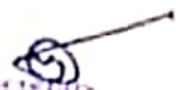
In presence of 2/3rd members of the total members, the quorum of the General Meeting will be formed, but no quorum in case of adjourned meeting is needed so far.

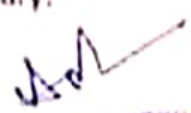
11. ELECTION PROCEDURE OF THE EXECUTIVE COMMITTEE:

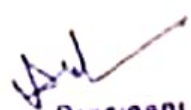
19. LEGAL PROCEDURE:
